TAARIFA YA WAZIRI WA NCHI OFISI YA RAIS - TAMISEMI MHE. INNOCENT BASHUNGWA (MB) KUHUSU MAPATO NA MATUMIZI YA MAPATO YA NDANI YA HALMASHAURI KWA MWAKA WA FEDHA 2021/22

1. Utangulizi

Ofisi ya Rais – TAMISEMI, inao utaratibu wa kutoa taarifa ya mapato na matumizi ya mapato ya ndani ya Halmashauri kwa kila robo mwaka ili kuongeza uwazi na uwajibikaji katika ukusanyaji wa mapato ya ndani ya Halmashauri nchini. Katika robo ya nne Ofisi ya Rais-TAMISEMI imeandaa taarifa ya mwaka ya mapato na matumizi ya mapato ya ndani ya Halmashauri kwa mwaka wa fedha 2021/22.

Taarifa hii imeainisha ufanisi wa kila Halmashauri katika ukusanyaji wa mapato ya ndani kwa kulinganisha makisio yaliyoidhinishwa na hali halisi ya utekelezaji. Aidha, taarifa hii imeonesha pia namna Halmashauri zilivyotekeleza vigezo vingine ambavyo vimeonekana ni muhimu pia vikafanyiwa tathmini kwa lengo la kuongeza uwajibikaji katika Mamlaka za Serikali za Mitaa. Hivyo, taarifa hii imejumuisha sehemu mbili, sehemu ya kwanza ikiwa ni ufanisi katika ukusanyaji wa mapato, matumizi ya makusanyo hayo ya ndani katika shughuli mbalimbali za kuwaletea Wananchi maendeleo ikiwemo matumizi ya mapato katika Miradi ya maendeleo, usimamizi wa mikopo ya asilimia kumi inayotokana na mapato ya ndani, utekelezaji wa mapendekezo ya CAG na namna Halmashauri zinavyoimarisha utawala bora kwa kuhabarisha umma juu ya shughuli mbalimbali zinatekelezwa na Serikali. Sehemu ya pili imetua taarifa ya tathmini katika vigezo vyote kwa kutoa alama kulingana na uzito wa kila kigezo na jinsi ambavyo Halmashauri imefikia alama za jumla.

2. Ufanisi katika Ukusanyaji wa Mapato kwa Mwaka wa Fedha 2021/22.

2.1. Ulinganisho kati ya makusanyo ya mwaka 2020/21 na 2021/22

Katika mwaka wa fedha 2021/22, Halmashauri zilipanga kukusanya **Shilingi Bilioni 863.9** kutoka kwenye vyanzo vya mapato ya ndani. Katika kipindi cha mwezi Julai hadi Juni 2022, Halmashauri zimekusanya **Shilingi Bilioni 888.7** ambayo ni **asilimia 103** ya makisio ya mwaka. Uchambuzi wa taarifa za mapato ya ndani ya Halmashauri katika mwaka wa fedha 2021/22 unaonesha kuwepo kwa ongezeko la mapato halisi yaliyokusanya kwa kiasi cha **Shilingi bilioni 131.7** ikilinganishwa na kiasi halisi kilichokusanya katika mwaka wa fedha 2020/21 cha **Shilingi Bilioni 757.1** sawa na ongezeko la **asilimia 17**. Kiwango hicho hakijawahi kufikiwa kwa kipindi cha miaka kumi iliyopita kwani Halmashauri hazijawahi kufikia malengo yao ya mwaka kwa asilimia 100 kama jedwari linavyoonesha hapa chini.

2.1.1. Mwenendo wa Ukusanyaji wa Mapato ya Ndani kwa Kipindi cha Julai – Juni, 2022

Uchambuzi umeonesha kuwa katika mwaka wa fedha 2021/22 Halmashauri **100** zimekusanya kwa **asilimia 100** au zaidi ya lengo la mwaka, Halmashauri **78** zimekusanya kati ya **asilimia 80** hadi **asilimia 99** na Halmashauri 7 zimekusanya kati ya asilimia **58** hadi **79**. Halmashauri zilizofikia malengo ya mwaka zimeongezeka kutoka Halmashauri **57** katika mwaka wa fedha 2020/21 hadi kufikia Halmashauri **100** katika

mwaka wa fedha 2021/22. Aidha, hakuna Halmashauri iliyokusanya chini ya **asilimia 50** kwa miaka yote miwili mfululizo.

Ulinganisho wa ufanisi wa ukusanyaji wa mapato ya ndani kwa kigezo cha asilimia ya makusanyo unaonesha kuwa **Halmashauri ya Wilaya ya Kibaha** imeongoza katika Halmashauri zote kwa kukusanya **asilimia 247** ya makisio yake ya mwaka ikifuatiwa na **Halmashauri za Wilaya ya Mlele asilimia 185** na **Halmashauri ya Wilaya ya Morogoro asilimia 158**. Ongezeko hili la asilimia limetokana Halmashauri ya Wilaya ya Kibaha kufanya mauzo ya eneo la uwekezaji ambayo hayakuwa sehemu ya bajeti ya Halmashauri hiyo. Pia Halmashauri ya Wilaya ya Mlele imekuwa na ongezeko la mapato kutokana na kushamiri kwa shughuli za kilimo na uwindaji baada ya kukamilika kwa barabara ya Tabora hadi Mpanda. Kumekuwa na ongezeko la ushuru wa huduma kutoka Bwawa la Mwalimu Nyerere kwa Halmashauri ya Wilaya ya Morogoro na Rufiji. Aidha, **Halmashauri ya Wilaya ya Bumbuli** imekuwa ya mwisho kwa kukusanya **asilimia 58** ya makisio yake ya mwaka ikifuatiwa na **Halmashauri ya Wilaya ya Korogwe asilimia 67** na **Halmashauri ya Wilaya ya Bunda asilimia 70** ya makisio yake ya mwaka (**Kiambatisho Na. 1A**).

Katika kuzipima Halmashauri zote kwa Kigezo cha wingi wa mapato (pato ghafi), jumla ya Halmashauri **35** zimekusanya zaidi ya **Shilingi Bilioni 5. Halmashauri ya Jiji la Dar es Salaam** imekusanya mapato mengi zaidi kuliko Halmashauri zote kwa kukusanya **Shilingi Bilioni 75.3** ikifuatiwa na **Halmashauri ya Manispaa ya Kinondoni Shilingi Bilioni 47.3** na **Halmashauri ya jiji la Dodoma Shilingi Bilioni 45.1**.

Aidha, Halmashauri **4** zimekusanya chini ya **Shilingi Bilioni 1** ambapo **Halmashauri ya Wilaya ya Bumbuli** imekua ya mwisho kwa kukusanya **Shilingi Milioni 599.7** ikifuatiwa na **Halmashauri ya Wilaya ya Kigoma Shilingi Milioni 692.1**, **Halmashauri ya Wilaya ya Madaba Shilingi Milioni 792.3** na **Halmashauri ya Wilaya ya Buhigwe Shilingi Milioni 880.2**. Halmashauri hizo pamoja na kuendelea kukusanya chini ya Shilingi Bilioni moja, zimeonekana kuongeza ufanisi katika ukusanyaji wa mapato. (**Kiambatisho Na 1B**)

Uchambuzi wa taarifa za mapato kwa kuzingatia ufanisi wa ukusanyaji wa mapato ya ndani ya Halmashauri Kimkoa unaonesha Mkoa wa **Pwani** umeongoza kwa kukusanya **asilimia 118** ya lengo la mwaka ikifuatiwa na Mkoa wa **Manyara asilimia 114**, Mkoa

wa **Katavi asilimia 112** na **Songwe asilimia 111**. Mkoa wa **Lindi** umekua wa mwisho kwa kukusanya **asilimia 87** ukifuatiwa na Mikoa ya **Mtwara na Geita asilimia 93 (Kiambatisho Na. 2A)**. Katika eneo hili ufanisi umeongezeka kwa kuwa katika mwaka wa fedha 2020/21 **Mkoa wa Lindi** ulikuwa wa mwisho kwa kuwa na **asilimia 78** na sasa Mkoa huo umepanda na kufikia **asilimia 87**.

Kwa kuzingatia wingi wa mapato (pato ghafi), Mkoa wa **Dar es Salaam** umekusanya mapato mengi zaidi kuliko Mikoa mingine kwa kukusanya **Shilingi Bilioni 167.5** ikifuatiwa na Mkoa wa **Dodoma Shilingi Bilioni 89.4** na Mkoa wa **Pwani Shilingi Bilioni 48.7**. Aidha, Mkoa wa **Rukwa** umekuwa wa mwisho kwa kukusanya **Shilingi Bilioni 9.4** ukifuatiwa na Mkoa wa **Katavi** kwa kukusanya **Shilingi Bilioni 13.6** na Mkoa wa **Simiyu Shilingi Bilioni 14.0**. Uchambuzi unaonesha kuwa Mikoa hii imeongeza ufanisi ikilinganishwa na mwaka wa fedha 2020/21 kwani Mkoa wa Rukwa ambao ulikuwa wa mwisho ulikusanya **Shilingi Bilioni 8.2**, Mkoa wa Katavi Shilingi Bilioni 9.7 na Mkoa wa Simiyu **Shilingi Bilioni 11.4**. Hata hivyo, Mikoa hii inakuwa ya mwisho kutokana na uchache wa Halmashauri. (**Kiambatisho Na. 2B**).

2.1.2. Ulingenisho kwa Kuzingatia Aina (Makundi) ya Halmashauri

a) Halmashauri za Majiji

Katika kipindi cha Julai hadi Juni 2022 **Halmashauri ya Jiji la Tanga** imeongoza kwa kukusanya mapato kwa **asilimia 113** ya makisio yake ya mwaka ikifuatiwa na **Halmashauri ya Jiji la Dar es Salaam asilimia 108**, **Halmashauri ya Jiji la Arusha asilimia 104**, **Halmashauri ya jiji la Dodoma asilimia 103**, **Halmashauri ya Jiji la Mwanza asilimia 100** na **Halmashauri ya Jiji la Mbeya** imekua ya mwisho kwa kukusanya **asilimia 92 (Kiambatisho Na. 3A)**.

b) Halmashauri za Manispaa

Halmashauri ya **Manispaa ya Shinyanga**, imeongoza kwa kukusanya mapato kwa **asilimia 125** ya makisio yake ya mwaka ikifuatiwa na Halmashauri ya **Manispaa ya Kigamboni na Ubungo asilimia 118** na Halmashauri ya **Manispaa ya Moshi asilimia 117**. Katika kundi hili Halmashauri ya **Manispaa ya Mtwara** imekuwa ya mwisho kwa kukusanya **asilimia 78** ya makisio ya mwaka ikifuatiwa na Halmashauri ya **Manispaa ya Lindi asilimia 90** na Manispaa ya Morogoro **asilimia 91 (Kiambatisho Na. 3B)**.

c) Halmashauri za Mji

Halmashauri ya **Mji wa Mbulu** imeongoza kwa kukusanya **asilimia 140** ya makisio ya mwaka ikifuatiwa na Halmashauri ya **Mji wa Mafinga asilimia 129** na Halmashauri ya **Mji wa Ifakara asilimia 125**. Aidha, Halmashauri ya **Mji wa Nanyamba** imekuwa ya mwisho kwa kukusanya **asilimia 71** ya makisio ya mwaka ikifuatiwa na Halmashauri za **Mji wa Korogwe asilimia 84** na **Halmashauri ya Mji wa Geita asilimia 88**. Halmashauri ya Mji wa Mbulu imeongeza ufanisi kwani kwa kipindi cha miaka mitatu mfululizo imekuwa ikishika nafasi ya mwisho kwenye Halmashauri za Mji kwa kukusanya chini ya Shilingi Bilioni moja kwa mwaka. (**Kiambatisho Na. 3C**)

d) Halmashauri za Wilaya

Halmashauri ya **Wilaya ya Kibaha** imeongoza kwa kukusanya **asilimia 247** ya makisio ya mwaka ikifuatiwa na Halmashauri ya **Wilaya ya Mlele asilimia 185** na Halmashauri ya **Wilaya ya Morogoro asilimia 158**. Aidha, Halmashauri ya **Wilaya ya Bumbuli** imekuwa ya mwisho kwa kukusanya **asilimia 58** ya makisio ya mwaka ikifuatiwa na Halmashauri ya **Wilaya ya Korogwe asilimia 67** ya makisio ya mwaka na Halmashauri ya **Wilaya ya Bunda asilimia 70** (**Kiambatisho Na. 3D**)

2.2. Matumizi ya Mapato ya Ndani ya Halmashauri

2.2.1. Matumizi katika Miradi ya Maendeleo (Development Expenditure)

Mamlaka za Serikali za Mitaa zimegawanywa katika makundi mawili katika kuchangia utekelezaji wa miradi ya Maendeleo kutokana na mapato ya ndani yasiyolindwa. Kundi la kwanza ni Halmashauri **17** zinazopaswa kuchangia **asilimia 60** na kundi la pili ni Halmashauri **167** zinazopaswa kuchangia **asilimia 40**. Uchambuzi wa taarifa za matumizi ya fedha za mapato ya ndani kwa mwaka wa fedha 2021/22, unaonesha kuwa Halmashauri zimetumia **Shilingi Bilioni 297.7** katika kutekeleza miradi ya maendeleo sawa na **asilimia 43** ya mapato yasiyolindwa ambayo ni **Shilingi Bilioni 689.5**. Halmashauri **3** zimetumia **asilimia 60** au zaidi ya kiasi cha mapato yasiyolindwa, Halmashauri **42** zimetumia kati ya asilimia **40 hadi 59** na Halmashauri **139** zimetumia chini ya **asilimia 40**. (**Kiambatisho 4**).

2.2.2. Ulinganisho wa matumizi kwa Kuzingatia makundi ya Halmashauri

a) Halmashauri zinazotenga asilimia 60 kwa ajili ya miradi

Katika kundi hili **Halmashauri ya Jiji la Dodoma** imeongoza kwa kutumia **asilimia 65** ikifuatiwa na **Halmashauri ya Wilaya ya Chalinze asilimia 62** na **Jiji la Arusha asilimia 62**. Aidha, **Halmashauri ya Manispaa ya Moshi** imekuwa ya mwisho kwa kutumia **asilimia 34** ikifuatiwa na **Halmashauri ya Manispaa ya Kinondoni asilimia 47** na **Halmashauri ya Manispaa ya Morogoro asilimia 49** ya mapato yasiyolindwa (*Kiambatisho 4A*).

b) Halmashauri zilizotenga asilimia 40 kwenye miradi

Katika kundi hili **Halmashauri ya Mji wa Njombe** imeongoza kwa kutumia **asilimia 51** ikifuatiwa na **Halmashauri ya Mji wa Tunduma** na **Halmashauri za Wilaya za Njombe na Mkuranga** ambazo zimetumia **asilimia 46** ya mapato yasiyolindwa. Aidha, **Halmashauri ya Wilaya ya Serengeti** imekuwa ya mwisho kwa kutumia **asilimia 16** ikifuatiwa **Halmashauri za Wilaya za Gairo** na **Bunda** ambazo zimetumia **asilimia 17** ya mapato yasiyolindwa (*Kiambatisho Na.4B*).

Uchambuzi wa matumizi unaonesha kuwa zipo baadhi ya Halmashauri ambazo zinauwezo mkubwa wa kuchangia zaidi ya kiwango cha chini kilichowekwa cha asilimia 40 au 60. Hivyo, katika mwaka wa fedha wa 2022/23 Halmashauri 5 zimebekwa kwenye kundi la kuchangia asilimia 70 kwa mwaka.

c) Mikopo ya asilimia 10

Uchambuzi wa taarifa za matumizi ya fedha za mapato ya ndani kwa kipindi cha Julai 2021 hadi Juni 2022, unaonesha kuwa Halmashauri zimechangia **Shilingi Bilioni 59.2** kwenye Mikopo ya Wanawake, Vijana na Watu Wenye Ulemavu, ambayo ni **asilimia 9** ya mapato yasiyolindwa **Shilingi Bilioni 674.8**.

Taarifa zinaonesha kuwa Halmashauri **48** zimechangia **asilimia 10** au zaidi, Halmashauri **135** zimechangia kati ya **asilimia 5** hadi **9** na Halmashauri **1** imechangia chini ya **asilimia 5** kwenye mikopo ya Wanawake, Vijana na Watu wenye ulemavu. Taarifa zinaonesha kuwa **Halmashauri ya Wilaya ya Bumbuli, Kilindi na Tandahimba** zimeongoza kwa kuchangia **asilimia 12** zikifuatiwa na Halmashauri za

Majiji ya Arusha, na Dar es Salaam, Halmashauri za Wilaya ya Hai na Madaba **asilimia 11**. Aidha, Halmashauri ya Wilaya ya Kibaha imekuwa ya mwisho kwa kuchangia **asilimia 3** ikifuatiwa na **Halmashauri za Wilaya ya Morogoro, Chato, Bukombe, Masasi** na **Nkasi** ambazo zimechangia **asilimia 5** (*Kiambatisho Na.5*).

2.3. Uchambuzi wa Uwazi na Uwajibikaji

Sehemu hii imechambua vigezo vya utawala bora na uwajibikaji. Uchambuzi umejumuisha taarifa za namna Halmashauri zilivyojibu hoja za ukaguzi za Mdhibiti na Mkaguzi Mkuu wa Hesabu za Serikali na namna Halmashauri zilivyowajibika kwa wananchi kwa kutoa mrejesho na kuhabarisha Wananchi juu ya shughuli mbalimbali zinazotekelawa Serikali.

2.3.1. Ujibuji wa Hoja na Utekelezaji wa Mapendekezo ya CAG

Uchambuzi umeonesha kuwa, Halmashauri ya **Wilaya ya Mtwara** imeongoza katika utekelezaji wa hoja na mapendekezo ya CAG kwa kutekeleza hoja na mapendekezo 92 kati 102 sawa na **asilimia 90**. Halmashauri ya **Wilaya ya Siha inafuatia kwa kutekeleza hoja na mapendekezo 65** kati **73** sawa na **asilimia 89**. Aidha, Halmashauri za Wilaya za Biharamulo, Serengeti na Nyang'hwale zimefanya vibaya kwenye eneo hili kwa kutekeleza mapendekezo kwa **asilimia 12**.

Halmashauri ya Manispaa ya Bukoba na Halmashauri za Wilaya za Muleba, Kyerwa na Karagwe hazijatekeleza mapendekezo na kufunga Hoja za CAG (*Kiambatisho Na. 6*).

2.3.2. Utoaji wa Mrejesho na Uhabarishaji Wananchi

Moja ya wajibu wa Halmashauri ni kuhakikisha fedha zinazopelekwa kwa Wananchi katika maeneo yao pamoja na miradi inayotekelawa inafahamika kwa Wananchi ili waweze kufuatilia na kusimamia matumizi sahihi ya fedha hizo. Sehemu hii imeonesha namna ambavyo Halmashauri ziliweza kuwajibika na kuongeza uwazi kwa Wananchi kwa kuhabarisha juu ya shughuli mbalimbali zinazotekelawa na Serikali ikiwemo Serikali Kuu na Serikali za Mitaa. Taarifa imeonesha jinsi Halmashauri zilizovyoweza kutumia vema tovuti zao kwa kuweka taarifa muhimu na kuhuisha kila taarifa zinavyopatikana. Katika eneo hili kwa kuanzia uchambuzi umefanyika kuangalia maeneo ya tarehe ya mwisho kuweka taarifa kwenye tovuti, uwepo kwa taarifa za

viongozi wapya, idadi ya taarifa (Mei na Juni) na uwepo wa taarifa za bajeti za Halmashauri zilizoidhinishwa na Bunge.

Uchambuzi umeonesha **Halmashauri ya Wilaya ya Gairo** imeongoza katika uhabarishaji Wananchi kwa **asilimia 89** ikifuatiwa na **Halmashauri ya Wilaya ya Ludewa 87** na **Halmashauri ya Wilaya ya Muheza asilimia 83**. Aidha, Halmashauri 68 za Mikoa 8 Mikoa haikuwasilisha na hivyo kushindwa kupimwa (**Kiambatisho Na. 7**)

3. Tathmini ya Jumla

Sehemu hii imeonesha tathmini ya ujumla kwa Halmashauri zote kwa kutoa alama kwenye vigezo vyta ukusanyaji wa mapato na matumizi ya mapato ya ndani, ujibuji wa hoja na utekelezaji wa mapendekezo ya CAG, utoaji wa mikopo ya asilimia 10, usimamizi na matumizi ya fedha za marejesho pamoja na matumizi ya Tovuti za Halmashauri katika kuhabarisha Wananchi.

3.1. Vigezo na Alama

i) Ukusanyaji wa mapato ya ndani (Alama 20)

Kigezo hiki kimezingatia kiwango cha makusanyo halisi ya Mapato ya ndani ikilinganishwa na bajeti ya mwaka.

ii) Matumizi ya mapato ya ndani katika miradi ya maendeleo (Alama 28)

Kigezo hiki kimezingatia jumla ya fedha za mapato ya ndani zilizotumika kwenye miradi ya maendeleo ikilinganishwa na fedha zilizopaswa kutumika kwenye miradi ya maendeleo kwa kuzingatia makusanyo halisi kwa kipindi cha Julai, 2021 hadi Juni 2022.

iii) Utoaji wa Mikopo ya asilimia 10 ya mapato ya ndani (Alama 10),

Kigezo hiki kimezingatia fedha zilizopelekwa kwenye vikundi vyta Wanawake, Vijana na watu wenye Ulemavu ikilinganishwa na fedha inayopaswa kupelekwa kwa kuzingatia mapato halisi katika kipindi cha Julai 2021 hadi Juni, 2022.

iv) Usimamizi wa urejeshaji wa Mikopo ya asilimia 10 (Alama 10).

Kigezo hiki kimezingatia namna Halmashauri zilivyosimamia ukusanyaji wa marejesho yaliyopaswa kuwa yamerejeshwa katika kipindi cha Julai, 2021 hadhi Juni, 2022

v) Matumizi ya Fedha za Marejesho (alama 10)

Kigezo hiki kimezingatia namna Halmashauri zilivyotumia fedha za marejesho kwa kuzingatia kanuni ya 23 ya Utoaji na Usimamizi wa Mikopo kwa vikundi vya Wanawake, vijana na watu wenyewe Ulemavu (kukopesha vikundi pamoja na usimamizi na ufuatiliaji)

vi) Ujibuji wa Hoja na Utekelezaji wa Mapendekezo ya CAG (Alama 20)

Kigezo hiki kimezingatia idadi ya hoja zote zilizojibiwa na kufungwa ikilinganishwa na Hoja zote za Halmashauri husika hadi kufikia Juni 2022.

vii) Utoaji wa Mrejesho na Uhabarishaji Wananchi kupitia Tovuti (Alama 2)

Kigezo hiki kimezingatia tarehe ya mwisho kuweka taarifa kwenye tovuti, uwepo kwa taarifa za viongozi wapya kwenye tovuti, idadi ya taarifa zilizowekwa mwezi Mei na Juni na uwepo wa taarifa za bajeti za Halmashauri zilizoidhinishwa na Bunge kwenye tovuti za Halmashauri.

3.2. Matokeo ya Tathmini ya ujumla

Katika kipindi cha Julai 2021 hadi Juni 2022, tathmini ya ufanisi wa utendaji wa Halmashauri ni **alama 80** kati ya 100. Tathmini hii imezingatia vigezo tajwa hapo juu ambavyo vimepewa uzito kulingana na umuhimu wake. Kutokana na tathmini hii, Ofisi ya Rais – TAMISEMI imekwishaanza kuchukua hatua kama kuwabadilisha vituo baadhi ya Wakuu wa Idara na Vitengo, kufanya msawazo kwa watumishi na kuwabadilishia majukumu baadhi ya Wakuu wa Idara na Vitengo kwa lengo la kuimarishe utendaji kazi na kuondoa utendaji kazi wa mazoea. Zoezi hili ni endelevu na ninamwelekeza Katibu Mkuu kuhakikisha msawazo unafanyika kwani Halmashauri zote zina haki ya kuwa na Watumishi hata katika uchache au upungufu uliopo wakati Serikali inaendelea na ujazaji wa nafasi wazi zilizopo.

Hatua nyingine iliyochukuliwa ni Katibu Mkuu kuitisha kikao kazi kilichojumuisha Makatibu Tawala wa Mikoa na Wakurugenzi wote. Lengo la kikao hicho ni kutafakari na kujadili kwa kina hali inayojitokeza katika usimamizi wa ukusanyaji wa mapato ya ndani, na utekelezaji wa Hoja za CAG. Nina imani kikao hicho kitaleta matokeo chanya na ifikapo Desemba, 2022 mtakwenda kufanya marejeo ya mapato ya ndani ya Halmashauri kwani kwa hali halisi inayojitokeza hakuna Halmashauri ambayo itakusanya chini ya Shilingi Bilioni 1 na pia zipo Halmashauri zinazokusanya mapato makubwa zinaweza kukusanya hadi zaidi Shilingi bilioni 100 isipokuwa yapo mapato mengi hayakusanywi na mengine yakikusanywa yanapotea.

Aidha, ili kuendelea kuimarishe uwajibikaji na utendaji kazi, katika mwaka wa fedha 2022/23 ripoti zitajumuisha vigezo zaidi vya sekta ya afya, elimu, miundombinu na utawala bora. Lengo ni kuzifanya Halmashauri ziongeze juhudini katika kuboresha huduma na kutatua kero za Wananchi. Vigezo hivyo vitatumika kama sehemu ya Mkataba wa utendaji wa Wakurugenzi, Wakuu wa Idara na Vitengo, Makatibu Tawala wa Mikoa na Makatibu Tawala Wasaidizi.

4. Maelekezo Mahsus

Wakuu wa Mikoa wanaelekezwa kutekeleza yafuatayo:-

- i) Halmashauri zihakikishe Fedha zilizovuka mwaka wa fedha 2021/22 (Bakaa) zinatumika kabla au ifikapo tarehe 30 Septemba, 2022 kwa kufuata Sheria, Kanuni, taratibu na miongozo. Katika eneo hili naelekeza kwamba Halmashauri zote zenye Bakaa ziwasilishe orodha ya miradi itakayotekeliza kwa fedha hizo kupitia Mikoa na ufanyike ufuutiliaji wa fedha hizo na kunipa taarifa ambayo

nitaitoa kwa Wananchi wakati nitakaposoma taarifa ya robo ya kwanza mwaka 2022/23.

- ii) Kuhakikisha bajeti za mapato ya ndani ya Halmashauri zinapangwa kwa kuzingatia uhalisia wa vyanzo vya mapato ili kuwa na maoteo halisi. Mfano, katika taarifa hii zipo Halmashauri ambazo zimekusanya zaidi ya asilimia 100 lakini hazikuwahi kuomba kuhuisha bajeti zao ili ziendane na uhalisia kama vile Halmashauri za Wilaya za Kibaha, Mlele na Halmashauri ya Mji wa Mbulu. Pia zipo baadhi ya Halmashauri ziliomba kupunguza bajeti zao hata hivyo mwisho wa mwaka zimekusanya zaidi ya asilimia 100 kama vile Halmashauri ya Jiji la Tanga, Halmashauri ya Manispaa ya Ubungo na Halmashauri ya Wilaya ya Serengeti. Vilevile zipo Halmashauri ambazo zimeomba kuongeza bajeti zaidi ya mara moja kama vile Halmashauri za Wilaya za Morogoro, Rufiji, Kaliua na Nyang'hwale hata hivyo bado zimekusanya zaidi ya asilimia 100.
- iii) Kuhakikisha Halmashauri ambazo hazikufanikiwa kukamilisha utekelezaji wa maagizo ya Mheshimiwa Waziri wa Nchi yaliyotolewa katika bajeti ya mwaka wa fedha 2021/22 zihakikishe zinakamilisha maagizo hayo kabla au ifikapo tarehe 30 Septemba, 2022 na kutoa taarifa Ofisi ya Rais – TAMISEMI.
- iv) Kuhakikisha ukaguzi wa Miradi ya Maendeleo katika Halmashauri unajumuisha ukaguzi wa Miradi inayotokana na mikopo ya asilimia 10 inayotolewa kwa vikundi vya Wanawake, Vijana na Watu wenye Ulemavu. Aidha, Mikoa ibainishe kiasi chote cha fedha za mikopo ya asilimia 10 ambacho hakijarejeshwa na kusimamia urejeshaji na kuwasilisha taarifa Ofisi ya Rais – TAMISEMI. Katika hili Mfumo wa Kielektroniki wa usimamizi wa mikopo hii upo tayari na umeanza kutumika. Ninaelekeza mkazisimamie Halmashauri zote na kuhakikisha vikundi vyote vilivyowahi kupata Mikopo na havijamaliza marejesho vinaingizwa kwenye Mfumo. Kazi ya kuingiza taarifa za vikundi hivyo iwe imekamilika ifikapo tarehe 30 Agosti, 2022. Na Katibu Mkuu atasimamia hili kuanzia tarehe 1 Agosti kuona ni Halmashauri zipi zinatekeleza na ambazo hazifanyi chochote kwa kuwa tutakuwa na uwezo wa kuona kuitia kwenye Mfumo. Watakwimu katika Halmashauri na Mikoa watumike ipasavyo. Serikali haitavumilia kuona bado

kuna fedha zisizorejeshwa au mikopo kutolewa kwa vikundi hewa au wanufaika wasiostahili.

- v) Halmashauri zote kutekeleza mapendekezo na kufunga hoja zote za ukaguzi zilizotolewa na CAG. Aidha, nasisitiza hili lifanyike pia kwa hoja za Mkaguzi wa Ndani wa Halmashauri ambapo kule kumekuwepo na hoja nyingi ambazo hazijafungwa na hoja hizo zimekuwa zikijirudia pia kwenye hoja za CAG.
