GoT-HoMIS

- The Government of Tanzania, Hospital Management Information System (GoT-HoMIS) is an electronic information system intended to:-
 - Collect and report facility level clinical information (basic patient level clinical dataset), and
 - Support Health Facilities in service delivery management.





 - Electronic Medical Record allows patient profile to be available across facilities through the use of centralized database






- Integration with other systems in the Health Sector


 GoT-HoMIS is also integrated with the Government Electronic Payment Gateway (GePG) to facilitate cashless environment at Health Facilities

- This support mainly goes to the development and maintenance efforts whereas infrastructure required at Health Facilities is the responsibility of the Facility or its Local Authority.


GoT-HoMIS at 170 Facilities

 Since GOT-HoMIS was adopted by the Government, it has been installed and used at 170 Health Facilities across the country (as of August, 2017) including major hospitals as:-

GoT-HoMIS at 170 Facilities

- The low coverage of facilities (170 out of 5000+) is mainly due to lack of support in installing the necessary ICT infrastructure to run the system.
- The Governemnt of Tanzania is welcoming Development Partners to join hand in realizing the dream of strengthening the country health information system by supporting installation/improvement of ICT infrastructure at health facilities.
